SURETY / WARRANTY / GUARANTEE

I, the APPLICANT/AUTHORISED representative of the Applicant (“the applicant”) hereby apply for a credit facility in the consideration whereof I bind myself and the applicant to the following conditions which I acknowledge I am fully acquainted with:

- a) A certificate signed by the Secretary or and Director of SPANNER TOOLS & INDUSTRIAL SUPPLIES C.C. (“the Creditor”), showing the amount owing by the Applicant at any one time and reflecting the amount thereupon as due and unpaid shall be sufficient and satisfactory proof of the effects therein stated for the purpose of any action., (whether by way of Provisional Sentence or otherwise) proof of debt on insolvency or for any purpose whatsoever.
- b) All overdue sums shall bear interest at the maximum interest allowed under the Limitation and Disclosure of Finance Charges Act No.73 or any act replacing it from the date upon which payment became due.
- c) Notwithstanding the amount which may at any time be owing, the Applicant consents in terms of Section45 of the Magistrate’s Court Act (No.32 of 1944, as amended) to jurisdiction of the Magistrate’s Court in any action or proceeding otherwise beyond it’s jurisdiction, it being understood however that the Creditors shall at all times be entitled to bring any such action or proceeding in the Supreme Court and if any such action be necessary the Applicant agrees to pay all costs as between attorney and client including collection commission and tracing charges, etc, if applicable.
- d) I, by my signature hereto, do hereby bind myself in my private and individual capacity as surety and co-principal debtor with the Applicant for the payment to the Creditor of any amounts which may at any time become owing to the Creditor by the Applicant from whatsoever cause arising. This guarantee shall be a continuing guarantee which may only be cancelled by the Applicant, by notice in writing to the Creditor and then only provided that all sums then owing by the Applicant (whether due or not), to the Creditor have been paid in full. I renounce the benefit of the legal exceptions “non causa debitis”, “ordinis seu excussionis et divisionis” and “cession of action” with the force, meaning and effect of which I declare myself to be fully acquainted.
- e) The Applicant agrees that all goods supplied are subject to the manufacturers guarantee or warranty as given by the manufacturer or by suppliers to SPANNER TOOLS & INDUSTRIAL SUPPLIES C.C. SPANNER TOOLS & INDUSTRIAL SUPPLIES C.C. shall not be held liable for any damage, whether consequential or otherwise as a result of defects in any of the goods supplied to the Applicant and shall be liable only to the extent of replacing such defective goods.

- i) The Applicant hereby cedes, assigns and makes over unto and in favour of the creditor all its rights, title and interest in and to all amounts of whatsoever nature presently owing or which may hereafter become owing to the Applicant by all the Applicant’s present and future debtors.

- k) Advices, recommendations or opinions by representatives of the creditors, are given and expressed in good faith, and shall not constitute representations of any description, and shall not give rise to any claims against the Creditor or such representatives.
